Total Laryngectomees in Skilled Nursing Facilities: Addressing the Gaps in Continuity of Care

2020

As hospital-based Speech-Language Pathologists (SLPs), we observed that many total laryngectomy (TL) patients are being discharged to skilled nursing facilities (SNFs), with frequent readmissions for stomarelated complications. Our experiences led us to believe that there is a serious deficiency in the knowledge of care and resources available for TLs at SNFs.

We sought to investigate this hypothesis by gathering information via questionnaire from SLPs in the field. We will present novel data that suggests key gaps in continuity of care of TLs at SNFs, including a lack of facility-level care protocols and limited competence and confidence among SLPs with regard to patient management. By presenting this data, we hope to stimulate discussion and generate solutions to better service this unique patient population.
